Thank you for visiting the BENDYANYA.com Website and for reviewing its Privacy Policy. This Privacy Policy applies to BENDY ANYA™, its Website [www.BENDYANYA.com](http://www.BENDYANYA.com) and its services. By visiting our Website or otherwise interacting with it, you agree to accept the practices described in this Privacy Policy. Its policy is clear:

### Information Collected and Stored Automatically
